1. **ROLL CALL** – President Zaugg called the meeting to order at 4 o'clock. Jotika Shetty confirmed that roll call was taken.
2. **APPROVAL OF THE MINUTES OF THE October 24, 2018 MEETING**

*A motion to approve the minutes of the October, 2018 meetings was made by Chriss Harris and seconded by Gene Parkinson and was duly passed by voice vote.*

3. **Program – “Mansfield Rising”**

A. **Mansfield Rising Report** –Jody Perry, Allie Watson and Jay Allred reported on the status of Mansfield Rising (formerly known as SXSU). The group consists of 15 people from all areas of Richland County, they have put in 100's of working hours and have created a 67 page document containing 31 ideas and are asking for support and approval from the Full Commission. Mansfield Rising has obtained approval from The Chamber of Commerce, RCDG and Richland County Foundation. The group has \$77,000 invested and the final draft of the plan will be available publically February 2019.

*A motion to approve the support plan of Mansfield Rising was made by Chriss Harris and seconded by Gene Parkison and was duly passed by voice vote.*

4. **EXECUTIVE DIRECTORS REPORT –**

Jotika highlighted the year in review. She stated Regional Planning is growing as an office and has sound practices in place. The office engaged in several collaborations in 2018 including GIS assistance, community committees, ODOT District 3 , the Transit Board, D16 and NRAC.

Site impact analysis studied 35 tube placements, 30 intersections and 3 speed zones.

Working with the Transit Board to make up a decrease in state funding through meetings with local leaders. Transportation planning conducted several surveys in order to obtain a capital grant.

The TIP managed several urban paving projects that were successful.

D16 was very successful for Richland County with over \$16 million in grants.

Jotika thanked the office staff for their help with the move to out new space and also thanked the Commissioners for the opportunity for the new space.

5. **PRESIDENT'S REPORT** – Marion thanked everyone for attending and for their hard work in the planning community. Asked that the Commission continue it's collaborative efforts with other organizations.

6. **Recognition of outgoing members and approval of new members**

The slate of new commission members were read and Marion asked for a motion to accept the slate as read.

*Darrell Banks made a motion to accept the new Commission Members as read, seconded by Gene Parkison, and was duly passed by voice vote.*

7. **Introduction of incoming President and Vice-President**

Marion introduced the new President Ellen Haring and new Vice-President Joe Gies.

8. **Commendation of Outgoing President**

Tim Bowersock presented Marion Zaugg with a plaque in appreciation of his service to the Commission and thanked him for his work on the new office space.
